

### **Note to File for Integrity Issue and MIT Failures**

This NOI states the proposed project was identified by CalGEM district engineers as involving remedial/rework to address well integrity issues that requires swift action for the protection of public health, safety, and the environment. The categorical exemptions that apply in this case include, but are not necessarily limited to Class 1, Existing Facilities, Cal. Code Regs., tit. 14, §§ 15301, 1684.1, Classes 7 and 8, Actions by Regulatory Agencies for Protection of Natural Resources and the Environment, Cal. Code Regs., tit. 14, §§ 15307, 15308, and may also include Class 2, Replacement or Reconstruction, Cal. Code Regs., tit. 14, § 15302, Class 4, Minor Alterations to Land, Cal. Code Regs., tit. 14, §§ 15304, 1684.2.

### **Notes to File for Sidetracks**

- For Sidetrack NOIs with a **non-integrity issue** paired with continued production, **no change in previously permitted well type, no change of zone**, and **no expanded production**, the note to file must read exactly like the following:

The proposed project was identified as involving remedial/rework to address continued permitted production. The categorical exemptions that apply in this case may include, but are not necessarily limited to Class 1, Existing Facilities, Cal. Code Regs., tit. 14, §§ 15301, 1684.1, and may also include Class 2, Replacement or Reconstruction, Cal. Code Regs., tit. 14, § 15302 and Class 4, Minor Alterations to Land, Cal. Code Regs., tit. 14, §§ 15304, 1684.2.

- For Sidetrack NOIs with **an integrity issue** paired with continued production, **no change in previously permitted well type, no change of zone**, and **no expanded production**, the note to file must read exactly like the following:

Code Regs., tit. 14, §§ 15307, 15308, and may also include Class 2, Replacement or Reconstruction, Cal. Code Regs., tit. 14, § 15302 and Class 4, Minor Alterations to Land, Cal. Code Regs., tit. 14, §§ 15304, 1684.2.

**Note to File for Reworks (Non-Integrity/ Non-MIT related)**

FID XXXXXX was reviewed, and categorical exemptions were determined to apply to this NOI pursuant to CEQA Statutes and CalGEM Regulations including Class 1 Existing Facilities (PRC 14 CCR §§ 15301, 1684.1), Class 2, Replacement or Reconstruction, (PRC 14 CCR § 15302), and Class 4 Minor Alterations to Land (PRC 14 CCR §§ 15304, 1684.2).

**Note to File for Active Leak**

**Note to File for P&A**

The categorical exemptions that apply in this case include, but are not necessarily limited to Class 1, Existing Facilities, Cal. Code Regs., tit. 14, §§ 15301, 1684.1 and Class 4, Minor Alterations to Land, Cal. Code Regs., tit. 14, §§ 15304, 1684.2, and may also include Class 2, Replacement or Reconstruction, Cal. Code Regs., tit. 14, § 15302. CalGEM further finds that there are no exceptions to the application of the categorical exemptions (PRC § 21084; 14 CCR § 15300.2 (c)) referenced above.
