



Statutory Requirements

- Public Resources Code (PRC) Section 3227: Monthly production, injection, and disposition reports ("monthly reports") are due on or before the last day of each month for the preceding calendar month.
- Monthly forms submitted after the PRC 3227 deadline are considered **late**.
- Any modification or update to a submitted form is considered an **amendment**.

Notice to Operators (NTO)



Notice To Operators (March 27, 2024)

WellSTAR Release 5.1.12 updates the OG110 Monthly Production, OG110B Monthly Injection, and OG110D Monthly Disposition ("monthly reports") forms in WellSTAR. With this update, submitted monthly reports (OG110, OG110B, OG110D) for previous calendar years will be subject to further review by CalGEM”

- Monthly Production / Injection
 - OG110 – Monthly Production
 - OG110B – Monthly Injection

- Monthly Disposition
 - OG110D – Monthly Disposition

- SB 1281 – Water Usage (Quarterly)
 - OG110Q – Quarterly Water Production
 - OG110BQ – Quarterly Water Injection
 - OG110FQ – Quarterly Other Water Allocation

- Annual Production
 - Form 122 – Annual Production

OG110 Monthly Production	Form used to report monthly production data from Operators.
OG110B Monthly Injection	Form used to report monthly injection data from Operators.
OG110D Monthly Disposition	Form used to report monthly disposition data from Operators.
110BQ Quarterly Water Injection	Allows Operators to report water injection data on a quarterly basis
110FQ Quarterly Other Water Allocation	Report quarterly water allocation data
110Q Quarterly Water Production	Allows Operators to report water production data on a quarterly basis
Form 122 Annual Production	Report annual production and operations

Frequently Asked Questions (FAQ)



1. Is EDD required to submit OG110D form?

-No. EDD is not required. If you don't have many fields with valid-for-report completions interval associated with your organization, you may choose to enter the data directly into the form. Select "No" in step 3. EDD Submission > navigate to step 4. Disposition Data > select Action > Add field to enter the data directly> Save.

2. Do I need to submit a late submission justification document to update current year's disposition record after the submission deadline?

-No, you do not need to submit a late submission justification document to update current's year data. However, the form will be reviewed by CalGEM.

3. Is a document required to be uploaded in the step 5. Document Upload. when submitting my OG110D?

-Except where late submission justification document is required, you are not required to upload any document during regular submission.

4. Why does my EDD contain errors?

-The EDD may contain bad data. Please check the EDD and ensure the data matches with the description in field description sheet.

5. Why is my EDD missing some fields?

-The field may no longer contain any valid-for-reporting completion interval associated with your organization for the reporting period.

6. Is the requirement for late submission justification document taken into effect already or do we have until March 1st 2025 to submit or update records of previous years?

-Yes, the requirement to submit a late submission justification document is already in effect. Please refer to NOTICE TO OPERATORS 2024-04 dated March 27, 2024.
