

Release Notes – R5.1.11 09/22/2023

These release notes provide high-level information about changes to WellSTAR functionalities in R5.1.11, including design change requests and defect fixes.

All Capabilities:

- WellSTAR messaging updated to replace Service Desk with WellSTAR Support at WellSTAR@conservation.ca.gov.

Bond:

- Bond Detail pages updated to display correct purpose and coverage values.
- Bond Information form updated to process for all bonds.

Entities:

- New Organization Questionnaire form updated to allow user to enter organization address and phone number.

Facilities:

- Plan Submission form approval updated to save uploaded documents correctly.

General:

- Form Submit Step updated to display date in Date Received field.
- Sub Task's Task Detail Page updated to include correct type and Review Link to associated form or page.
- Release 5.1.9 Release Notes added to Help section.
- Validation messages updated to contain contextual information.

Idle Well:

- Idle Well Form EDD misspelled label corrected.

Inspections:

- Explore Data – Inspections grid updated to return correct results when filtering by Inspection Date.
- Inspection Detail – Timesheet section updated to show date(s) and time(s) entered by inspector.
- Downloaded Inspection Data into FI includes Counties for Settings, Leases, Pipelines.
- FI Search page and grids updated to support layered filtering and sorting once filters are applied.
- Inspection Summary document updates:
 - Duplicated No. Of Violations field corrected.

- Uploaded Documents grid added.
 - Resolved Violations grid added.
- FI Restore function fixed.

Production:

- Monthly Production and Monthly Injection EDD templates updated to use dropdowns for NoDaysWellProduced and NoDaysWellInjected.

Public Access:

- Additional Document categories made available for direct download.
- ADA Accessibility and PRA notes added to Documents sections.

UIC:

- Analytical Sample Data Detail page updated to include CAS Numbers for all constituents.
- Application for Injection Approval form updates:
 - EDD validation for injector entries to match associated completion interval Field, Area, Pool combinations.
 - Requirement for wellbore code when Planned Use = Area of Review, non-required fields disabled.
 - Misspelled labels corrected.
 - UIC Project Wells EDD updated to include new Field, Area, Pool combinations.
 - UIC Conditions of Approval template updated, custom ordering within category allowed in Associated CoA's grid.
 - Wells Associated to the UIC Project pre-populate Well Verification step from UIC Project Detail page when UIC Project Wells EDD is not uploaded into the form.
- UIC Project Detail page updates:
 - Wellbore Code added to Area of Review wells grid.
 - Misspelled labels corrected.

Well Management:

- Explore Data – Wells grid updates:
 - Uses daily cache to resolve performance issues.
 - Added Injection Suspended, Next Test Type, and Idle Well information columns.
- Stratigraphic added for use as Well Type.
- Notice of Abeyance and Permit documents updated to include Date Received and Date Issued.

- Well cancellation document language updated to specify required Bond Release Request.
- Well Detail – Production grid updated to include Wellbore Code, Pool Code, Pool Name and Completion Interval Type columns.
- Well Events updated to display Date/Time in PST.
- Well Summary form updates:
 - Well status rollup logic removed from V1/V2.
 - Version 5 allows Effective Date to be assigned in Completion Interval pop-up.
- Well Information form updates:
 - Version 4 allows Effective Date to be assigned in Completion Interval pop-up.
 - Validation added to require a user visits Well Information step before form submittal.
- Notice of Intention form updates:
 - CEQA Review task moved to occur after NOI Technical Review.
 - Requires Associated Bond before approval of Final Determination task.
 - Associated Bond checked for number of wells allocated at time of association and before approval.
 - Operator Status on Do Not Permit List checked at form creation, submittal and approval. Warning message on Form Information, Submit and Review steps.
- Upload Test Result form updates:
 - Step Rate Test enforces requirement for CalGEM Approved Fracture Gradient.
