This document will provide descriptions of each capability and the functionality being implemented within each capability.

WellSTAR Alternate Procedures

The following are known defects being implemented and the associated alternate procedures for WellSTAR Release 5.1.8. These defects are being prioritized by the primary CalGEM stakeholders and fixes will be implemented based on the priority set by the business.

Release 5.1.8 enhancements and new forms being implemented are:

All Capabilities:

- Merge Coastal district into Northern district.
- Updated CalGEM address now in correspondence text and correspondence headers.

Bonds:

- Date added to Bond Information form in Transaction Type Pop-up.
- Modify bond with previous cash payment does not error out.
- Bond Number link opens Bond Detail page.
- Financial Instruments Grid/ Transaction Type Grid actions restored.

Entities:

- New entities can now create their profile without needing an internal user to submit form.

Facilities:

- Add Violations Section to Component Detail Page.
- Associated Component grids display with Lease ID.
- Associated counties to Tanks corrected.
- Facility Information form does not error out with multiple tanks.
- Component Test Due Dates display on Facility Detail page.

General:

- Subject ID link now returns user to correct API from My Tasks, Tasks and Forms Submitted grids.
- Lease Detail page allows filtering and export from grid.

Idle Well:

- Idle Well Form sorting issues resolved.
- Idle Well Page error out on export corrected.
- Emails correctly send from Batch Job well status updates. ##### Inspections:
- Inspections List page displays a unique row for each Inspection ID and Subject ID with form names comma delimited.
- Inspection Detail Page:
- Inspected Subjects grid lists Field and Lease columns.
- Inspection Documents grid contains Subject ID column.
- Inspection Timesheet information available.
- Inspection emails sent to Operator updated.
- Inspection Summary format issues corrected.

Operator Total Liability:

- Operator Total Liability Detail Grid type column is now default hidden.

Transfers:

- Transfer grid displays dates correctly.
- Transfer Detail Page displays dates correctly.

UIC:

- PAL Closing Text order corrected.
- EDD updated to increase the number of rows available and decrease processing time.
- Well Designation displays in Application for Injection Approval form.

UGS:

- UGS Project Detail displays the correct Project ID.

Well Management:

- Upload Test Result:
 - Lease ID appended to Select/Associate grids.
 - Associated Inspections and Test Due Dates display for associated API.

- New validation on Step 9 to confirm test form has been associated to subject on Step 3.
 - Snapshot displays correct Well Designation.
- Well Detail:
 - Additional fields added to Well Detail – Tests grid.
 - Cancel/Close Events written when permit status is updated.
 - Test Due Dates display correctly.
 - Upload Test Result links restored.
