

Release Notes – R5.1.9 10/27/2022

These release notes provide high-level information about changes to WellSTAR functionalities in R5.1.9, including design change requests, and defect fixes.

WellSTAR Alternate Procedures

The following are known defects being implemented and the associated alternate procedures for WellSTAR Release 5.1.9. These defects are being prioritized by the primary CalGEM stakeholders and fixes will be implemented based on the priority set by the business.

Release 5.1.9 enhancements and new forms being implemented are:

Bonds:

- Bond Information form:
 - Form failure fixed for Bonds with large number of wells.
 - Requires Bond Effective and Transaction Dates, Radio option for Guarantor is WellSTAR Organization.

Entities:

- Organization Detail – Documents Grid now includes Document ID.

Facilities:

- Facility Information Form:
 - Validation added to prevent equipment descriptions over 100 characters.
 - Nodes are now able to be removed from pipelines.

General:

- Document Upload of same name file allowed once original is removed.
- Form error on an open form when new form created in separate browser tab resolved.

Idle Well:

- Idle Well Fee Invoice Form:
 - EDD step added into form.
 - Form generation of fee letter now optional.

- Duplicate invoice fee letter generation resolved.
- Idle Well Batch sets Idle End Date when updating Well to Active.
- Idle Well Batch corrects Idle Start Date if tardy production reported, sets new test due dates.
- Idle Well Batch updated to analyze for Active wells up to 24 months in the past.

Inspections:

- Field Inspection Module:
 - Facility Group now available within Inspection Groups.
 - Lease Landing page now contains Violations column for Select Wells/Facilities grids.
 - Dynamic forms now available when inspection UIC or UGS projects.
 - Search page now defaults filter type to 'Starts With', unsupported filters removed.
 - Clear evaluation button added to Evaluation Pop-Up.
- Inspection Detail Page:
 - Subject ID appended to documents grid.
 - Inspection Timesheet section now available.
 - Inspections associated to Complaints/Incidents in FI now associated on respective detail page.

Production:

- Quarterly Water Injection allows up to 8 digits for reporting.
- Production list page loads successfully when searching by District.
- Cancelled wells no longer appear in Monthly reporting forms.
- Form 122-Annual Production updates for volumes reported under PRC 3238.

Public:

- Public User can export larger data sets using Export – Excel function.
- Public User can access Well Stimulation detail page, neighbor notification grid not displayed.

Transfers:

- Data fix of past transfers for date of ownership.
- Transfer form approval migration resolved.

UIC:

- Analytical Sample Data Submission form:
 - Displays Operator and Lab Acknowledgements.
 - External Operator cannot create new instance of form.
 - Sample Category not required until CA Certified Lab acknowledgment received.
- Application for Injection Approval form:
 - Form timeout on Step 10 when greater than 1000 wells resolved.
 - All project types now display in Draft Project Approval Letters.
 - MOA Agency Users can now use Preview PAL Button.
 - Upload Date within forms in flight now reflects most recent date document uploaded.
 - Reason for Modification field made required when application type is Modify.
 - EDD processing improved when uploading larger data sets.
 - EDD provided Review Decision and attributes now display in Wells grid.
 - When using form to transfer project, project wells prepopulate within the form.
 - When using form to transfer project, review decision is not required.
 - Type of Modification is now editable during Type of Modification Determination task, and after form returned to Forms In Progress.

UGS:

- Assessable Wells Grid will reflect type and status when well was deemed assessable.
- Manually added COA's now display Category in Project Approval Letter.
- Project Approval Letter no longer cuts off phone number in salutation.

Well Management:

- Versions 2 and 3 of NOI and Well Summary aligned with Version 4.
- New Well Summaries will display P-Code and Category on Summary Review.
- Final Letters will use Agent Address.
- NOI Abeyance Timer corrected for submissions after 5 pm.
- Upload Test Result 'Was test witnessed by CalGEM' defaults to blank unless Witness or Waived.
- Notice of Abeyances issued without NOI Correspondence step information populated will no longer contain missing information.
- Older version NOI's now calculate Permit Expiration date off Date Received.

- Error message resolved when Surface Location Lat/Long match with Directional Survey Lat/Long.
- All well classifications now able to be removed using Well Information form.

Well Stimulation:

- Background processing of Well Maintenance form in Maintain Mode resolved.
- 72-Hour Notification submitted snapshot generates correctly.
- Well Detail and Well Stimulation Detail pages location information now match.
