#### NOTICE TO OPERATORS NTO 2018-14

#### WELLSTAR - NEW AND UPDATED FORMS, AND ELECTRONIC REPORTING

The Division of Oil, Gas, and Geothermal Resources (DOGGR) has successfully deployed Release 3.0 of its new Well Statewide Tracking and Reporting (WellSTAR) system. With this recent Release, and prior Releases of WellSTAR, DOGGR has increased its ability to provide for electronic reporting of monthly injection and production data submitted by operators. During this process DOGGR issued an NTO (NTO 2018-03), which provided operators with reporting leniency on the following forms; OG110, OG110B, OG110D, 110Q, 110BQ, and 110FQ. The leniency was provided to ensure that operators had ample time to make any system changes that may be needed to accommodate for the Division's reporting requirements.

This NTO is to inform operators DOGGR is re-aligning with its statutory requirements and expects operators to provide monthly and quarterly production/injection reporting and quarterly water reporting to DOGGR as was previously required prior to the issuance of NTO 2018-03. Operators are expected to be up to date on quarterly and monthly production/injection, and quarterly water reporting by January 15, 2019. WellSTAR is designed to automatically notify operators of any late reporting. This notification is now active in WellSTAR. If you receive these notifications please ensure that the following forms are up to date; OG110, OG110B, OG110Q, OG110BQ, and OG110FQ.
