THE STATE MINING AND GEOLOGY BOARD

THE BOARD

The State Mining and Geology Board (Board) serves as a regulatory, policy, and appeals body representing the State's interests in the reclamation of mined lands, geology, geologic and seismologic hazards, and the conservation of mineral resources.

The Board was established in 1885 as the Board of Trustees to oversee the activities of the Sate Mineralogist and the California Division of Mines and Geology (now the California Geological Survey). It is second oldest Board in California. Today's Board has nine members appointed by the Governor and confirmed by the State Senate, for four-year terms. By statute, Board members must have specific professional backgrounds in geology, mining engineering, environmental protection, groundwater hydrology and rock chemistry, urban planning, landscape architecture, mineral resource conservation, and seismology, with one member representing the general public.

Mission Statement

The mission of the Board is to provide professional expertise and guidance, and to represent the State's interest in the development, utilization, and conservation of mineral resources, the reclamation of mined lands and the development and dissemination of geologic and seismic hazard information to protect the health and welfare of the people of California.

STATUTORY AND REGULATORY AUTHORITY

The Board is an independent entity within the Department of Conservation under the Natural Resources Agency and is granted responsibilities and obligations under the following acts:

Surface Mining and Reclamation Act of 1975

Under this Act, Public Resources Code Sections 2710 et seq. and its regulations at 14 California Code of Regulations Section 3500 et seq., the Board provides a comprehensive surface mining and reclamation policy to assure that adverse environmental impacts are minimized, and mined lands are reclaimed. SMARA also encourages the production, conservation, and protection of the State's mineral resources.

Alquist-Priolo Earthquake Fault Zoning Act

Under this Act, Public Resources Code Section 2621 through Section 2630, and its regulations at 14 California Code Regulations Section 3600 et seq., the Board is authorized to represent the State's interests in establishing guidelines and standards for geological and geophysical investigations and reports produced by the California Geological Survey, public sector agencies, and private practitioners. The Board is also authorized to develop specific criteria through regulations to be used by Lead Agencies in complying with the provisions of the Act to protect the health, safety, and welfare of the public.

Seismic Hazards Mapping Act

Under this Act, Public Resources Code Section 2690 through Section 2699.6 and its regulations at 14 California Code of Regulations Section 3720 et seq. the Board is authorized to provide policy and guidance through regulations for a statewide seismic hazard mapping and technical advisory program to assist cities, counties, and State agencies in fulfilling their responsibilities for protecting the public health and safety from the effects of strong ground shaking, liquefaction or other ground failure, landslides and other seismic hazards caused by earthquakes, including tsunami and seiche threats.

Meeting was called to order by Chair Sheingold at 10:06 am.

2. Pledge of Allegiance

Jeffrey Schmidt led the Pledge of Allegiance

Deputy Director Tiffany also gave an update on the Department's budget deficit, and that the deficit will not affect the general fund for CGS seismic Instrumentation project. The department is now working toward developing the 2024-25 budget. - Division of Mine Reclamation Report (Campbell)
 Cameron Campbell discussed the wind down of recent work performed by CalGEM and Cal OES in Tulare County to prepare the area for potential flooding due to snowmelt. He also discussed upcoming mine inspector workshops that will be held in Oceanside California in August and in Sacramento, California in November. Cameron also discussed meeting with CalGEM regarding SB 125, Lithium extraction, and necessary modifications for the annual reporting form to accommodate annual Lithium extraction reporting. He also discussed recent work performed by the AML Unit in Nevada County to mitigate subsidence that caused a surficial opening.

 Jeff Newton discussed recent work performed by CGS on post wildfire debris flows and landslides that have been prevalent due to this years heavy rainfall. He also discussed funding for new positions with CGS's seismic instrumentation program. CGS has grown 30% over the last 5 years. He also discussed a new executive position that will be opening in the near future.

Nomination of the State Geologist

BACKGROUND:

The State Mining and Geology Board (Board) nominates, and the Director of the Department of Conservation appoints the State Geologist.

STATUTORY AND REGULATORY AUTHORITY:

PRC Section 677: The Board shall nominate, and the director shall appoint, the State Geologist, who shall either be registered in compliance with the Geologist and Geophysicist Act (Chapter 12.5 (commencing with Section 7800) of Division 3 of the Business and Professions Code) at least one year from the date of appointment, or the Board for Professional Engineers and Land Surveyors may, upon the review of academic and professional experience, grant registration. The State Geologist shall possess general knowledge of mineral resources, structural geology, seismology, engineering geology, and related disciplines in science and engineering, and the reclamation of mined lands and waters. The State Geologist shall advise the director regarding technical, scientific, and engineering issues, including the scientific quality of the division's products and activities.

DISCUSSION:

Two candidates for the position of the State Geologist were screened by the Department of Conservation and provided to the Board for potential nomination. Subsequently, an Ad Hoc Committee of the Board was formed to interview the candidates for the State Geologist position. On August 2, 2023, the Ad Hoc committee members determined that both Jeremy Lancaster and Diane Barclay are qualified to be the California State Geologist and nominates them for the position.

SUGGESTED MOTION:

Board Chair and Members, considering the information before the Board today, I move that the Board approve the Ad Hoc committee's recommendation to nominate Jeremy Lancaster and Diane Barclay as qualified to be the State Geologist and to transmit their names to the Director of Conservation.

Certification of the San Benito County Updated Surface Mining Operations and Reclamation Ordinance Title 19, Chapter 19.13 as being in accordance with State Policy and the Surface Mining and Reclamation Act (Public Resources Code Section 2710 et seq.).

Discussion:

The San Benito County's surface mining ordinance (ordinance) was last certified by the State Mining and Geology Board (Board) in 1999. On August 16, 2022, San Benito County (County) contacted the Board and provided a draft mining ordinance for review and comment. To confirm the ordinance met the minimum requirements of the Surface Mining and Reclamation Act (SMARA), Board staff provided comments, recommendations and met several times with County staff and their consultant, Benchmark Resources. In addition, the Board's legal counsel also reviewed the updated ordinance. Subsequently, the County Planning Commission held several public hearings and eventually recommended adoption of the ordinance by the Board of Supervisors. On July 25, 2023, the San Benito County Board of Supervisors adopted San Benito County Code, Title 19, Chapter 19.13 "Surface Mining Operations and Reclamation."

Authority:

Pursuant to Public Resources Code (PRC) Section 2774(a), a lead agency is required to adopt ordinances in accordance with state policy which establish procedures for the review and approval of reclamation plans and financial assurances and the issuance of a permit to conduct surface mining operations.

PRC Section 2774.3 states that "the Board shall review lead agency ordinances which establish permit and reclamation procedures to determine whether each ordinance is in accordance with state policy and shall certify the ordinance as being in accordance with state policy if it adequately meets, or imposes requirements more stringent than, the California surface mining and reclamation policies and procedures established by the board pursuant to this chapter."

PRC Section 2774.5 states that "if, upon review of an ordinance, the board finds that it is not in accordance with state policy, the board shall communicate the ordinance's deficiencies in writing to the lead agency. Upon receipt of the written communication, the lead agency shall have 90 days to submit a revised ordinance to the board for certification as being in accordance with state policy. The board shall review the lead agency's revised ordinance for certification within 60 days of its receipt."

Executive Officer Recommendation:

The Executive Officer concludes that San Benito County's revised surface mining ordinance meets the minimum requirements of SMARA and that the SMGB certify the updated ordinance as being in accordance with state policy and SMARA.

Board Chair and Members, considering the information before the State Mining and Geology Board today, I move that the Board certify San Benito County's mining ordinance Title 19, Chapter 19.13 as being in accordance with state policy and the Surface Mining and Reclamation Act.
