
# Sample Map inside of HPZ @ 1:12,000





The proposed project consists of Abandonment of NOI Well 3, which requires a permit from CalGEM. The duration of well work spans 3-5 days.

### **Health Protection Zone Statement**

NOI Well 3 is inside a Health Protection Zone with numerous sensitive receptors. Due to the density of receptors within 3200 ft of the wellhead just a few representative ones are described. The well lies in the middle of a financial / commercial district alongside a busy intersection with several businesses open to the public within 3200 feet of the well. Two large residential neighborhoods are located to the west and southeast of the well. A hotel lies immediately 460 ft to the east. Two parks are further to the east, one at 1000 ft and another 1600 ft away. An elementary school is located 1600 ft to the southwest. Two churches are nearby, one roughly 1600 ft to the northeast and another 2600 ft to the southeast. There are medical offices approximately 2500 ft to the north, northwest, and northeast. There is a us post office 2500 ft to the south southwest.



The proposed project consists of a workover of NOI Well 4, which requires a permit from CalGEM. The duration of well work spans 3-5 days.

### **Health Protection Zone Statement**

NOI Well 4 is not located inside a Health Protection Zone. It lies off of Highway 46, roughly 7 miles west-northwest of Blackwell's Corner. This well has no sensitive receptors located within a 3200 ft radius of the well location. There is a structure located roughly 1100 feet to the northeast of the wellhead, but this location is a non-sensitive receptor. It is a warehouse / shed that is used in oilfield operations and is not open to the public.
