PRE-RULEMAKING PUBLIC COMMENT PERIOD ON THE DEVELOPMENT OF UPDATES TO THE REQUIREMENTS FOR PIPELINES

The Department of Conservation, Division of Oil, Gas, and Geothermal Resources (DOGGR) has publicly released two sets of pre-rulemaking draft regulations (Discussion Drafts) for the purpose of receiving public input on the development of updates to the Requirements for Pipelines regulations implementing AB 1420 (Salas, Chapter 601, Statutes of 2015). **Public comment can be submitted through July 21, 2017.**

The Division will be conducting one public workshop to provide information and to solicit input from the public on the Discussion Drafts. The public workshop is scheduled for the following date and location:

BACKGROUND

This public comment period is part of an informal, pre-rulemaking process to develop regulations, and all interested parties are encouraged to participate.

Both Discussion Drafts address new requirements for active gas pipelines, particularly those pipelines that are less than 4" in diameter or more than 10 years old, and that are located in sensitive areas, as defined by AB 1420. One Discussion Draft relates to active gas pipeline testing and inspection and Pipeline Management Plans. The second Discussion Draft relates to active gas pipeline mapping and data submission requirements for operators.
